HCZ Promise Academy I promotes high achievement in all subjects through a demanding curriculum, extensive supportive services, and the use of data-driven teaching methods. HCZ Promise Academy I is committed to promoting academic accomplishment, positive character development, healthy lifestyles, and leadership skills. In partnership with the Harlem Children's Zone, HCZ Promise Academy I addresses the educational and developmental needs of each student.

KDE 1	Data-driven Instruction: Promise Academy believes that all students have different instructional needs, and it is our job to find ways to identify and address those needs. We are committed to collecting and analyzing data both in and out of the classroom. Our goal is to place equal emphasis on quantitative and qualitative data as it pertains to academics and social development. We collect and effectively analyze scholar performance data and create actionable plans to address deficiencies.
KDE 2	Training & Professional Development: Professional Development is a critical part of the daily functionality at Promise. Principals and teachers attend PD sessions to improve targeted practices and promote proficiency. Education directors and instructional coaches develop improvement plans

	<p>for educators. Teachers participate in "Go Live" practice lessons where they receive feedback from an administrator. Teachers also have access to an extensive network of PD opportunities through our external partnerships.</p>
KDE 3	<p>College Readiness: Promise Academy scholars will graduate ready for college and the career of their choice. The high school offers advanced placement courses that prepare scholars to meet college and career readiness standards during instruction. Scholars engage in community service, college exposures, and a variety of internships to become culturally informed. They are offered services from the Center for Higher Education and Career Support with advisors who help and guide them.</p>
KDE 4	<p>Pipeline of Services: We offer a pipeline of services such as healthy nutrition, access to social services, foster care prevention, and an after-school with additional opportunities that ensure our students begin on the same playing field as children from more affluent communities. We also have a fully operational health center at our main building for all Promise students and partner with proven organizations so that our children get the services they need to develop as healthy students.</p>
KDE 5	<p>Social and Emotional Learning: SEL is embedded in school culture and drives school-wide practices and policies. Promise Academy uses five core competencies as its SEL framework: self-awareness; self-management; social awareness; relationship skills; and responsible decision making. All are directly and indirectly incorporated into core subjects. Promise has a long-term vision to implement K-12 sequential curriculum and programming to support SEL development in Promise Academy scholars.</p>
KDE 6	<p>RTI: Promise Academy uses Response to Intervention (RTI), a multi-tiered approach that ensures early identification of scholars who need support to succeed academically. Teachers first identify scholars who are scoring below 80 percent or who are exhibiting behavioral challenges. They</p>

	monitor the scholars' progress and provide evidence-based interventions, which are continuously reviewed, assessed, and adjusted depending on each scholar's responsiveness.
KDE 7	Recruitment: The recruitment team focuses on finding quality candidates from around the country and works with leadership using the following strategies: attending/hosting teacher recruitment fairs and events at colleges/universities, internet job postings, advertisements, employee referrals, and partnering with programs such as Teach for America. Student-teachers from reputable universities are trained in Promise classrooms with a focus on data-driven positive school culture.
KDE 8	Parent Engagement: Promise Academy has a strong focus on connecting with the parents of its scholars, who are instrumental in the educational process. There are four parent coordinators across the school that assist with parent outreach and engagement. The Promise Academy II Parent Association (PAPA II) helps to maintain strong ties between staff and families. The school also has a parent representative on the board of trustees to ensure that families always have a voice.

Acceptance of Minutes (Geoffrey Canada)

The meeting was called to order at 7:00 a.m. and a motion was called to approve the meeting minutes from June 19, 2019. The motion was unanimously approved.

CEO Report (Anne Williams-Isom)

Anne Williams-Isom thanked everyone who joined in the 25th Annual Children's March for Peace, which was renamed the Rasuli Lewis Children's March for Peace to honor the HCZ director who passed away this summer and who was one of the original organizers of the Peace March.

Ms. Williams-Isom reported that more than 3,000 children were part of the annual HCZ Summer Games held in July at the Fort Washington Avenue Armory.

The Promise Academy High School graduation was held on June 26th. The keynote speaker, performer and entrepreneur Pharrell Williams, offered summer 2020 internships to the entire graduating class.

September 5, 2019 was the first day of school for all Promise Academy I and II scholars. Principals and senior staff members stood in front of the schools in the mornings of the first two days to greet scholars and their families.

Ms. Williams-Isom and Dr. Achil Petit sat down with teachers to do evaluations after the test scores were released.

Cindy Baah, the founder of Determined to Educate, provided the Promise Academy I Middle School with R&B artist Michael Bivins as a keynote speaker for the eighth-grade graduation in June. Determined to Educate is an organization devoted to supporting New York City's most vulnerable young student populations through group mentoring.

Superintendent's Update (Dr. Achil Petit)

Dr. Petit reported that enrollment is at 1,201 for Promise Academy I and at 1,056 for Promise Academy II.

Dr. Petit also reported PAII High School principal Katherine Hurtado resigned her position. Kashif Hameed, the former PAI Middle School principal, will take her place and Madelaine German-Schultz, who was the Education Director under Mr. Hameed, has accepted the role of principal for PAI Middle School. Ms. German-Schultz thanked the superintendent for the opportunity. The board welcomed Ms. German Schultz and Mr. Hameed to their new roles.

State Test Scores (Dr. Bessie Wilkerson / Dr. Achil Petit)

Dr. Bessie Wilkerson spoke about State test results, comparing the results of Promise Academy I and II to the results of students in the district, City, State and New York City black and white students.

In ELA, PAI and PAII performed better than all above mentioned comparison groups except for NYC white students. Dr. Wilkerson discussed both schools' growth percentage from 2013 to 2019. In addition, the pass rates for students with disabilities for Promise Academy exceeded New York City rates.

Dr. Petit discussed the ELA goals and initiatives during the 2018-2019 school year that contributed to an increase in proficiency rates for PAI and steady proficiency rates for PAII. The goals included small group instruction based on assessment data, improved levels of questioning during observations, improved pacing of instruction, Go-Live coaching, modified curriculum based on data, use of Academic Intervention Services (AIS) to address deficiencies, Saturday School, updated exit tickets and benchmark exams and increased academic hour during test preparation.

In math, PAI and PAII outperformed all above mentioned comparison groups including NYC white students. Dr. Wilkerson discussed both schools' growth percentage from 2013 to 2019. Both Promise Academies have demonstrated much greater growth over that time period than the standard comparison groups. Additionally, the passing rates for students with disabilities for Promise Academy exceeded New York City rates.

Dr. Petit discussed the math goals and initiatives during the 2018-2019 school year that contributed to an increase in proficiency rates for PAI and PAII, which included providing actionable feedback during teacher observations, modifying the curriculum based on 2018 State test data, an increased focus on test preparation, weekly grade team meetings, weekly Go-Live sessions with new teachers, data meetings, incentivized academic hour, targeted aggressive monitoring and increased use of technology.

Dr. Wilkerson reported on Regents exam results for PAI and PAII high school students, comparing Promise scores to the 2018 results for black and white New York State students and all New York State students as a whole. PAI and PAII high school senior cohorts outperformed all New York State comparison groups in all five of the required Regents exams. Even prior to their senior year of high school, Promise Academy cohorts were already passing Regents exams in most subjects at rates higher than NYS's students as a whole. This is true for the 2018-2019

junior cohort in all five subjects, true of sophomores in some subjects, and true for freshmen in math.

HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was at 84% for July.

During the summer session, the elementary school focused on improving reading levels across grades K through 5. The school created another leveled reading library on the second floor.

Students went on two trips during the summer. The first was to the New York Historical Society, where scholars went on a scavenger hunt looking for artifacts. The second was to the Museum of the City of New York, where scholars participated in the "future lab" and students looked at different ways to design New York City that took into account sociological factors, environmental factors, and urban design.

The first day of school was successful and scholars were enthusiastic to be back at Promise Academy.

A book vending machine has been installed, where scholars can use tokens to check out high interest books. The school has a partnership with The Book Fairies, a not-for-profit organization that collects reading materials for people in need throughout New York City. The organization will be supplying the school with books throughout the school year.

The school will hold its back-to-school night on September 12, 2019.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school's attendance was at 79% for July.

Over the summer, three middle school scholars were given the opportunity to participate in the Youth Climate Summit at the United Nations on September 21, 2019. The scholars representing Promise Academy at the summit will discuss different reasons and possible solutions for climate change.

School leaders and teachers participated in restorative practice training and have seen a positive difference in interactions between scholars and teachers.

Ms. Kyler Morris, a seventh-grade math teacher, was cited for working closely with her students for test preparation, with 95% of her scholars earning proficiency on the NYS math exams.

HCZ Promise Academy I High School (Bridget O'Neill)

The high school's attendance was at 85% for July.

97% of the senior class has met their graduating testing requirements. School leaders are working with the remaining 3% to meet benchmarks.

Scholars engaged in summer exposure opportunities at The Wharton School of the University of Pennsylvania, New York University, Syracuse University, Harvard University and Susquehanna University. One of the senior students won first place at the University of Pennsylvania for creating a proposal for an app that would give underprivileged students viable options for

summer exposure programs. The senior scholar presented in front of more than 200 students and board members.

PAI and PAII scholars in the Forces of Nature dance team went on a trip to South Africa for ten days engaging in volunteer community projects.

In partnership with the College Board, the high schools have been working with two new curricula, Pre-AP and SpringBoard, to ensure college readiness for Scholastic Aptitude Tests (SATs). School leaders have been working closely with teachers in developing college readiness and all freshmen teachers went to a four-day training institute over the summer. School leaders will be closely monitoring implementation of the new curricula.

Financial Report (Jim Hutter)

PAI's enrollment is at 1,201, which is 73 students favorable. PAI revenue is on track with its budget. PAI is \$200,000 favorable with expenses at \$2.9M. There is no HCZ contribution through the first two months of FY20.

The meeting was called to order at 7:00 a.m. and a motion was called to approve the meeting minutes from September 11, 2019. The motion was unanimously approved.

CEO Report (Anne Williams-Isom)

Anne Williams-Isom and Dr. Betina Jean-Louis spoke about the work of Dr. Michael Lindsay - professor and executive director of the McSilver Institute for Poverty Policy and Research at NYU. Dr. Lindsay is a child and adolescent mental health researcher whose work focuses on the impact of mental health in the African American community. He has partnered with Promise Academy and the Institute of Family Health to identify children who may be suffering from depression to support their families with appropriate resources.

Ms. Williams-Isom distributed a booklet about Promise Academy's Cultivating Excellence Initiative to the board, a document that clearly defines the schools' efforts to build on strengths and identify weaknesses to improve practices across the Promise Academy Charter Schools.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is at 1,144 for Promise Academy I and at 1,044 for Promise Academy II. Dr. Petit also thanked the principals and the Promise Academy Central Office for their outreach efforts during the enrollment period.

Dr. Petit reported the resignation of Promise Academy I High School principal Zahida Aminy. Education Director Bridget O'Neill will be acting principal until the role is filled. Dr. Petit also thanked the Central Office Director of Operations, Toya Stilley, PAI High School Educational Director of STEM Dr. Chanelle Cox, and the PAI High School Operations Director Monique Misty for their efforts to support the high school during this time of transition.

Deputy of Special Projects Susan Rydz will give the updates for PAI High School.

HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was at 95% for September. School leaders continue to meet with parents to discuss the importance of getting their scholars to school every day.

To further efforts regarding social-emotional learning, PAI Elementary has been starting each day with "community circles" in the classrooms. These restorative practices continue to help build a sense of community, emotional awareness and empathy among students.

In honor of a former student who passed away from sickle cell anemia, Promise Academy I recited the Promise Academy Creed together on Sickle Cell Awareness Day.

"Back-to-school" night was held on September 12th with 301 parents attending.

The first parent-teacher conference of the year was held to discuss students' progress with 412 parents attending.

The newly elected board of the Promise Academy I Parents Association (PAPA I) met with principal Dr. Cordero to discuss ways in which they can work with the administrative staff to support the school.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school's attendance was at 97% for September. School staff members will make efforts to ensure high attendance.

Academic Dean Camil Alassan created the "Brothers Initiating Growth and Greatness" program (B.I.G.G.) to ensure that middle school boys are consistently mentored and engaged in community service to help build character.

Middle school girls are volunteering with City Harvest to distribute produce to the residents of the Saint Nicholas community.

Parent-teacher conferences were held on October 17th with 150 parents attending.

HCZ Promise Academy I High School (Susan Rydz)

The high school's attendance was at 96% for September. Staff members will continue outreach efforts to ensure good attendance.

97% of the senior class has met their graduating testing requirements. School leaders are working with the remaining 3% to meet benchmarks.

Parent-teacher conferences were held in October.

High school juniors took the PSAT exam on October 16th. After, students were treated to a trip to the movies.

Seniors went on a college tour to visit SUNY Oswego, Binghamton University and Syracuse University.

On October 10th, the school held a "FAFSA Night" to give parents and seniors an opportunity to complete their FAFSA forms. More than 80% of parents attended and had one-on-one meetings with advisors. The remaining parents and seniors completed their forms in the following week.

To further efforts in social-emotional learning, 9th and 10th graders have completed group projects on social justice, with a focus on self-identity as well as learning how to relate to others in their social groups. Students in the 11th grade have been exploring their passions, their values and their purpose and 12th graders have been exploring their strengths and weaknesses, what it means to have a “growth mindset” and the importance of emotional awareness.

Financial Report (Sara Alvarado)

PAI’s enrollment is at 1,144, which is 16 students favorable. PAI revenue is on track with its budget. PAI is \$200,000 favorable with expenses at \$4.8M. There is no HCZ contribution through the first three months of FY20.

Grant Thornton is currently performing the audit of FY18 for PAI. Once the audit is complete, the audited financial statements and report on internal control will be filed with the New York State Education Department by the November 1st deadline.

English Language Learners Preference Resolution (Candice Ashby)

A motion was called to add an English Language Learners (ELL) preference to the kindergarten lottery for Harlem Children’s Zone Promise Academy I Charter School. The Board unanimously approved the resolution. A detailed version of the resolution can be found within the October 30, 2019 board packet on the Promise Academy website.

Teacher Presentation (Dr. Achil Petit)

Each teacher from Promise Academy I and II who had the highest percentage of scholars earn proficiency on the New York State exams were honored at the board meeting.

In PAI, fifth-grade math teacher Elleace David had 81% of her students score proficient and seventh-grade teacher Kyler Morris had 95% scholar proficiency. At PAII, fifth-grade math teacher O’Mara Galvez’s students earned 75.5% proficiency. 100% percent of the students in Education Director Ryan Carroll’s eighth-grade class scored proficient, with those same students passing the Algebra I Regents exam.

The teachers spoke on their methods in the classroom that contribute to student success, including analyzing data closely and teaching their scholars to have a “growth mindset.”

As a partner of HCZ and Promise Academy, DTE invites professionals to visit HCZ staff and scholars for inspirational talks on career and life choices. The elementary school's attendance was at 95% for October.

Staff engaged in professional development including workshops in intellectual data analysis, increasing literacy, special education referrals and social-emotional learning. Physical education teachers also attended a professional development event at Adelphi University.

The New York Fire Department spoke to first graders about careers as firefighters during a visit to the school.

Students took a trip to Queens County Farm and learned about quilt-making.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,124 for Promise Academy I and 1,024 for Promise Academy II.

Dr. Petit informed the board that the Promise Academy I Parent Association (PAPA I) held a very successful event with 138 parents attending. Employees from HCZ programs, including Baby College and Healthy Harlem, attended and offered families information about services. Dr. Petit thanked Director of Parent and Community Engagement, Latasha Morgan, for emceeding the event and After-School staff member Morgan Bello for providing music.

Promise Academy I and II have been focusing on aligning practices across both charter schools with the joint events, including Black History Month celebrations, Counselor Appreciation Week, and Scholly Night, where parents are encouraged to register their children in an online scholarship database that matches students with potential college funding opportunities. HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was at 94% for January

The school held a Martin Luther King assembly, where kindergarten and first-grade students performed a rendition of the "I Have a Dream" speech.

Second graders went to see *Alice in Wonderland* off-Broadway to reinforce the Common Core fairy tale reading units of study that the scholars are currently learning.

Scholars in grades three through five, held a winter showcase using the theme, *Dreamgirls*, based on the Broadway musical. Over 400 people showed up for the event.

The author Brandon Frame of the book *My First Tie*, visited the school to talk to the Young Kings group. Mr. Fame taught the scholars how to tie a tie. The Young Kings are a group of young male scholars who are receiving extra support.

The kindergarten, first and second-grade scholars held an art show.

In celebration of Black History Month, scholars in grades kindergarten through second are introduced daily to information about influential African Americans. There is also a reading challenge, and scholars are borrowing books on black history or books written by African American authors. Students are also decorating their classroom doors for Black History Month, and the winning class will receive a prize.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school's attendance was at 95% for January.

Students are taking advantage of the extra help offered at Saturday Academy.

The school held an honor roll ceremony. Honor roll students will also enjoy a trip to Sky Zone Trampoline Park. The top seven scholars of every grade will receive a gold tie, and the top 15 scholars will have a special meeting with the superintendent.

The Robin Hood Foundation arranged for middle school scholars to attend a professional basketball game, with the New York Knicks playing the Miami Heat. Scholars also spoke with Knicks legends John Starks and Allan Houston. Middle school scholars played at the Barclays Center and won.

HCZ Promise Academy I High School (Susan Rydz)

The high school's attendance was at 95% for January.

A group of high school scholars attended *A Soldier's Play* on Broadway, which raises important social issues. Scholars read and analyzed the play in theater class and then also watched the film version before seeing the play.

Both Promise Academy I and II high school students are engaged in a J.P. Morgan program called Project Live, where students pair up with mentors to work on different projects and learn about financial literacy.

In celebration of Black History Month, scholars are going to see the film *Just Mercy*, based on a true story about an African American civil rights defense attorney working towards freeing a wrongly condemned death row prisoner.

In line with the school's theme for the month, social justice, the humanities teachers have been working closely with scholars to look at historical examples of people who have overcome adversity and applying these circumstances to their communities and their own lives.

The Promise Academy I Parent Association (PAPA I) event was successful, with 138 parents attending to learn about the supports that are available for their children.

Financial Report (Jim Hutter)

PAI's enrollment is at 1,124, which is four unfavorable versus the budget. PAI revenue is \$100,000 unfavorable versus the budget. PAI is \$100,000 unfavorable with expenses at \$11.9M. There is no HCZ contribution through seven months of FY20.

Art Student Showcase

Artwork created by PAI Elementary School students was on display, and Ms. Rachael Senchaway, the art teacher, presented and answered questions about the works. Ms. Senchaway also explained that the goal for younger students was to develop motor skills to improve writing.

Anne Williams-Isom reported the continuing efforts to protect staff members and scholars during the Coronavirus crisis, including communications to families and staff on prevention and safety, increased sanitization of all Harlem Children's Zone buildings, increased Coronavirus preventive measures, signage throughout the organization, and ensuring that hand sanitizer is strategically placed in all classrooms, offices and entrances.

Ms. Williams-Isom also reported that all non-essential gatherings and travel have been canceled throughout the organization and that a steering committee has been created to address any changes and issues that may occur as a result of the Coronavirus crisis.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,118 for Promise Academy I and 1,014 for Promise Academy II.

Dr. Petit informed the board that all teachers and academic staff have been trained in Google Classroom and Zoom video conferencing in the event of a school closure.

Financial Report (Sara Alvarado)

PAI's enrollment is at 1,118, which is 10 unfavorable versus the budget. PAI revenue is \$100,000 unfavorable versus the budget. PAI is on target with expenses at \$13.4M. There is no HCZ contribution through eight months of FY20.

The meeting was called to order at 7:00 a.m., and a motion to approve the meeting minutes from March 10, 2020 was unanimously approved.

CEO Report (Anne Williams-Isom)

Anne Williams-Isom reported that she has been meeting remotely every day with the senior management team to offer guidance and inspiration.

CEO-elect, Kwame Owusu-Kesse, introduced two new senior executives who have been hired to fill the roles of Chief Operations Officer (COO) and Senior Managing Director of Programs.

Dr. Nana Annan, who will be serving as COO, has had 22 years of experience to date. Prior to joining HCZ, she served as COO of the Boys Club of NY and has worked with many non-profit organizations focused on education, development, and advocacy, such as Brooklyn Generation School, United Nations Development Programme, Kids in Need of Defense, and Greater Boston Legal Services. Ms. Annan has a Juris Doctorate from Boston University School of Law and a Bachelor of Science in computer science from Spelman College.

Wesner Pierre, the new Senior Managing Director of Programs, has over a decade of experience, most recently at CAMBA, where he served as Vice President of Educational Youth Development. Mr. Pierre was a 2015 participant in the American Express Leadership Academy and holds a Bachelor of Arts in Urban Legal Studies from City College and a master's degree in Urban Affairs from Queens College of the City University of New York.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,116 for Promise Academy I and 1,011 for Promise Academy II.

Dr. Petit reported on the schools' progress in response to closures in alignment with the New York City Department of Education (DOE). Virtual learning continues to be successful, with high student attendance. Teachers are providing live instruction via virtual learning platforms. One hundred and forty-five hot spots and 1,000 laptops were distributed to students and families, with many families sending notes of gratitude for the support and high level of instruction that their children are receiving remotely. Dr. Petit thanked Ms. Williams-Isom and Mr. Owusu-

Kesse for their support and guidance in keeping scholars and families safe. Dr. Petit also thanked PAII Middle School Principal Amy Deal and Director of Information Systems Ari Browne for ensuring that all staff were trained on virtual learning platforms.

Additionally, Dr. Petit reported that, in response to the warnings that hackers have been infiltrating learning platforms, security measures had been implemented to protect scholars and staff. Additionally, Promise Academy leaders will continue to monitor progress on keeping security measures in place.

HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was at 89% for March. The lowest days were due to the transition to virtual learning.

In early March, prior to school closures, Kappa Alpha Psi Fraternity members partnered with Read Across America to visit the school and read to students in several elementary classes. The students were featured on NBC's Today Show for a segment on Read Across America. As a surprise, students received hundreds of books on-air as part of a live book fair.

Google Classroom training was held on March 9th in response to the COVID-19 pandemic and in case of a school closure.

The elementary school held parent-teacher conferences virtually, with high parent participation. Additionally, sessions with the principal are held regularly.

Live virtual instruction began on March 17th for the elementary school. Each morning begins with social-emotional learning and virtual community circles. Scholars have an hour and a half of ELA and math instruction with quizzes and assessments taking place in real-time. Teachers have live office hours to support parents one-on-one. Special education and counseling services are given in the afternoon.

School leaders are checking in with staff members daily as a team and in smaller groups. Also, elementary staff members are taking advantage of virtual workouts offered by physical education teachers. Virtual professional development opportunities have also been available to teachers. Technology support continues to be offered daily.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school's attendance was at 98% for March. School administrative staff have been consistently calling parents to make sure every child is logging in for instruction daily.

Teachers with more advanced technological knowledge have been coaching their peers who require additional tech support. Middle school teachers have also been providing a remote academic hour for students who need it.

Students receive remote social-emotional learning daily with staff members checking in with students during virtual one-on-one sessions. Students also engage in physical education online.

Assessments and quizzes are given frequently to scholars to ensure they are engaging with the material and mastering the content.

HCZ Promise Academy I High School (Bridget O'Neill)

The high school's attendance was at 96% for March.

All high school staff members were trained in remote learning platforms. Remote learning began for every PAI high school student on March 19th.

The high school has created a technology support hotline so that parents and students can access support in real-time.

School leadership has been meeting with teachers and staff frequently to offer support and guidance.

School leaders have shifted to open-ended assessments, which tasks high school students with creating original work.

High school students receive remote social-emotional learning and physical education.

School leaders are running virtual town halls and pep rallies for both students and parents to share information and offer support and guidance.

Financial Report (Jim Hutter)

PAI's enrollment is at 1,116, which is 12 unfavorable versus the budget. PAI revenue is \$300,000 unfavorable versus the budget. PAI is \$200,000 favorable with expenses at \$14.9M. There is no HCZ contribution through nine months of FY20.

CEO Report (Anne Williams-Isom)

CEO-elect Kwame Owusu-Kesse introduced a new senior executive hired to fill the role of Managing Director of Internal Engagement and Public Policy - Hayling Price. Mr. Price joined the team in January 2020. He earned his bachelor's degree from the University of Pennsylvania, his master's degree in Public Policy from Harvard Kennedy School, and an MBA from Harvard Business School. Most recently, Mr. Price worked as a consultant for FSG; a firm focused on social impact.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,116 for Promise Academy I and 1,011 for Promise Academy II.

Dr. Petit also reported that enrollment for the new school year is underway, with systems put in place to help parents fill out and submit documents remotely.

Attendance continues to be high for remote learning.

Additionally, Dr. Petit reported that schools had found innovative ways to celebrate their staff members for Teacher Appreciation Week.

HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was 95% for April.

The school has been holding weekly pep rallies on Friday mornings for second graders.

Families and staff have been volunteering to read the book of the month to children virtually. The book for April focused on the character trait "persistence."

Students have been attending virtual field trips to zoos, caves, and other exciting places.

Specials teachers have been creating virtual galleries to display students' works in art, Spanish, dance, and physical education.

The boys' group, Young Kings, continues to meet with the principal remotely for guidance and mentorship.

The school engaged in an organization-wide effort to survey Promise families who may have been affected by the Coronavirus pandemic. The elementary school completed 500 surveys in less than three days.

The school holds a virtual jam session with parents on Tuesdays and Thursdays. Parents discuss a wide range of topics and recently shared recipes from their cultures.

Director of Social-Emotional Learning, Deirdre Schwiring, spoke to parents remotely about mental and emotional wellness for kids and families. Additionally, social workers have been checking in with families to support them. The principal also consistently checks on staff members to offer them support.

A team-building event was held for all staff members.

The school held a virtual honor roll ceremony. High school senior Mariama Barry and HCZ CEO Anne Williams-Isom were keynote speakers.

In celebration of Teacher Appreciation Week, students created collages to thank teachers. Staff members and teachers also received thank-you letters from families and the principal. Staff leaders purchased shirts for the staff as well and led some games remotely for the team as part of the celebration.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school's attendance was 99% for April. The high attendance was due to intense efforts by the staff to check in with families.

In technology, scholars are taking ownership of their learning by creating instructional videos and using them to teach their peers. Their final works were viewed in a virtual gallery walk.

Deirdre Schwiring spoke to scholars about emotional wellness and practicing self-care. School leaders have been working closely with the social work team to ensure that the school is connected with all families and scholars regularly.

Staff members were celebrated during Teacher Appreciation Week. Parents wrote thank-you notes for teachers and staff members. Staff received customized sweaters and other gifts. Teachers even wrote thank-you notes to each other.

HCZ Promise Academy I High School (Bridget O'Neill)

The high school's attendance was 95% for April.

On April 7th, virtual pep rallies were held for each grade. Pep rallies are held weekly, exploring different themes, such as "Demonstrating Resilience in the Virtual Setting." Raffles and prizes are awarded during these events.

The school held a virtual town hall for parents on April 8th, where staff leaders conducted an open forum for parents to speak about additional supports needed.

On April 22nd, a virtual party for eighth-grade parents gave families a chance to ask questions about high school.

Care packages were sent to college-bound seniors in celebration of National Decision Day. A pep rally was held on May 1st to celebrate the college decisions.

The school partnered with Success in Motion to allow teachers to take online daily physical fitness classes.

Scholars watched plays remotely and took virtual museum tours for visual and theater arts. They also learned about Frank Lloyd Wright with a virtual tour sponsored by the MOMA.

Teachers were given customized sweatshirts and other gifts for Teacher Appreciation Week.

School leaders are meeting with families and scholars to help with financial aid packages and to monitor important college deadlines for enrollment and deposits.

CEO Report (Anne Williams-Isom)

The Promise Academy I & II Board of Trustees conveyed their gratitude for the great work of Anne Williams-Isom in her roles as Chief Executive Officer of Harlem Children's Zone and President of the Promise Academy Boards of Trustees. The Board also welcomed CEO-elect Kwame Owusu-Kesse in his new role.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,116 for Promise Academy I and 1,011 for Promise Academy II.

Dr. Petit reported on his plan to create more opportunities for professionals to speak to scholars about racial equality in the upcoming school year.

A planning committee is currently in place to create reopening plans for Promise Academy schools in the fall, with a strong focus on safety for all staff and students.

The Promise Academy High School graduation will be held virtually on June 26, 2020, at 10 a.m.

Dr. Petit thanked principals, Kashif Hameed, Dr. Joseph Cordero, and Amy Deal; and HCZ human resources recruiters for holding a webinar for potential teachers last week, with 84 participants attending the event.

HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)

The elementary school's attendance was 95% for May.

Students, teachers, and social workers spoke together about social unrest and civil justice to help scholars process the protests and discussions sparked by the death of George Floyd. The principal also wrote a letter to staff members to encourage them.

The school deans have been conducting a virtual reading room series from 12-1 p.m. daily, which also allows students to access Accelerated Reader.

The school is in the process of completing Instructional Reading Level (IRL) testing to ensure that scholars are meeting benchmarks.

The scholars continue to take virtual field trips.

The book of the month explored the character trait “patience.”

“Moving Up” graduation ceremonies for kindergarten scholars and graduation celebrations for fifth graders are scheduled for June 22, 2020. Dr. Cordero thanked Ms. Schultz for meeting with the parents of transitioning sixth-grade scholars.

Director of Social-Emotional Learning Deirdre Schwiring had a jam session with parents to share best practices in speaking to children about the COVID-19 crisis.

Professional development events for staff members have helped to inform them of the HCZ services that are available for students.

Teachers received tokens of appreciation for Teacher Appreciation Week. Additionally, the staff participated in a virtual game event.

HCZ Promise Academy I Middle School (Madelaine Schultz)

The middle school’s attendance was 98% for May.

To address the current social unrest, school leaders have been checking in with scholars and teachers during morning meetings. Staff members have been able to voice concerns and receive guidance on how to handle distress and conversations on civic injustice.

During history and ELA classes, students have engaged in student-led advocacy to create safe ways to have their voices heard, such as writing letters to political leaders in their borough and city.

Students participated in a virtual poetry slam, which gave them a creative outlet to express their feelings. School leaders have been collaborating with the social work team for additional support.

In science classes, students engaged in a virtual scavenger hunt.

The school continues to host “Fun Fridays” with virtual games for staff.

The middle school has shared best practices with staff to help with the learning process.

PAI High School Principal Bridget O’Neill spoke with parents of eighth-grade scholars about their transition to high school.

75% of students have participated in study hall during breaks.

The middle school has partnered with PAI Elementary School to have jam sessions for the parents of transitioning fifth graders.

HCZ Promise Academy I High School (Bridget O’Neill)

The high school’s attendance was 94% for May.

School leaders continue to give teachers opportunities to express concerns about teaching during the COVID-19 pandemic.

High school students are working with the learning community to express their feelings.

Operations director Sean Harrell, head dean Charlene Nevett, and Ms. Schwiring gave talks about racial injustice.

On June 4th, there was a professional development session with team-building exercises and a stress workshop for staff members led by the Success in Motion wellness organization.

School leaders met with teachers to discuss the HCZ Pillars of Wellness and Mental Health and how best to support high school scholars.

A 10th-grade scholar, Valley Diallo, was chosen to be the ambassador for the O'Brien Youth Leadership this summer.

The school has continued partnering with Robin Pogrebin, a "New York Times" reporter. Ms. Pogrebin offers writing guidance for our rising seniors as they prepare personal statements for college applications.

Scholars who are working to meet benchmarks continue to attend Saturday Academy for extra support.

Preparation is underway for the Promise High School virtual graduation ceremony on June 26th at 10 a.m.

Acceptance of Minutes (Geoffrey Canada)

The meeting was called to order at 7:30 a.m., and a motion to approve the meeting minutes from June 9, 2020, was unanimously approved.

CEO Report (Kwame Owusu-Kesse)

Harlem Children's Zone's (HCZ's) newly appointed Chief Executive Officer, Kwame Owusu-Kesse, thanked the board for welcoming him in his first official Board meetings for Promise Academy I and II.

Mr. Owusu-Kesse also reported that HCZ gave over 150 new bikes to children in the community this month.

Last week, HCZ held a modified Healthy Harlem harvest, where the organization gave out 4,000 pounds of fresh produce, 1,000 2-week supply packages of non-perishable foods, 1,000 masks, and 400 thermometers to families in the community.

The Harlem Children Zone continues to take a national leadership role, particularly with the response to COVID-19, given the devastating impact the pandemic has had on communities of color. Six cities have adopted HCZ's approach, which includes: Oakland, Minneapolis, Detroit, Chicago, Atlanta, and Newark. We have been successful.

HCZ has been successful in raising 26 million dollars towards a 50 million dollars broader national effort.

Mr. Owusu-Kesse gave a virtual TED Talks highlighting the national leadership role that HCZ is taking.

Superintendent's Update (Dr. Achil Petit)

Dr. Achil Petit reported that enrollment is currently 1,116 for Promise Academy I and 1,011 for Promise Academy II.

Dr. Petit also reported that June attendance for Promise Academy I & II remained in the 90s.

The schools held virtual ceremonies in June, including graduations and moving up events for kindergarten, fifth graders, eighth graders, and high school seniors.

Schools held a virtual Career Day with over 100 career professionals speaking with kids.

Virtual summer sessions have been progressing well, with scholars receiving project-based learning and high school students receiving credit recovery. Virtual enrichment activities take place in the afternoon, including art, fitness, robotics, coding, and media arts.

The Recovery Committee is working towards creating a reopening plan that will keep scholars and staff safe. The committee's planning is informed by New York State and local health authorities.

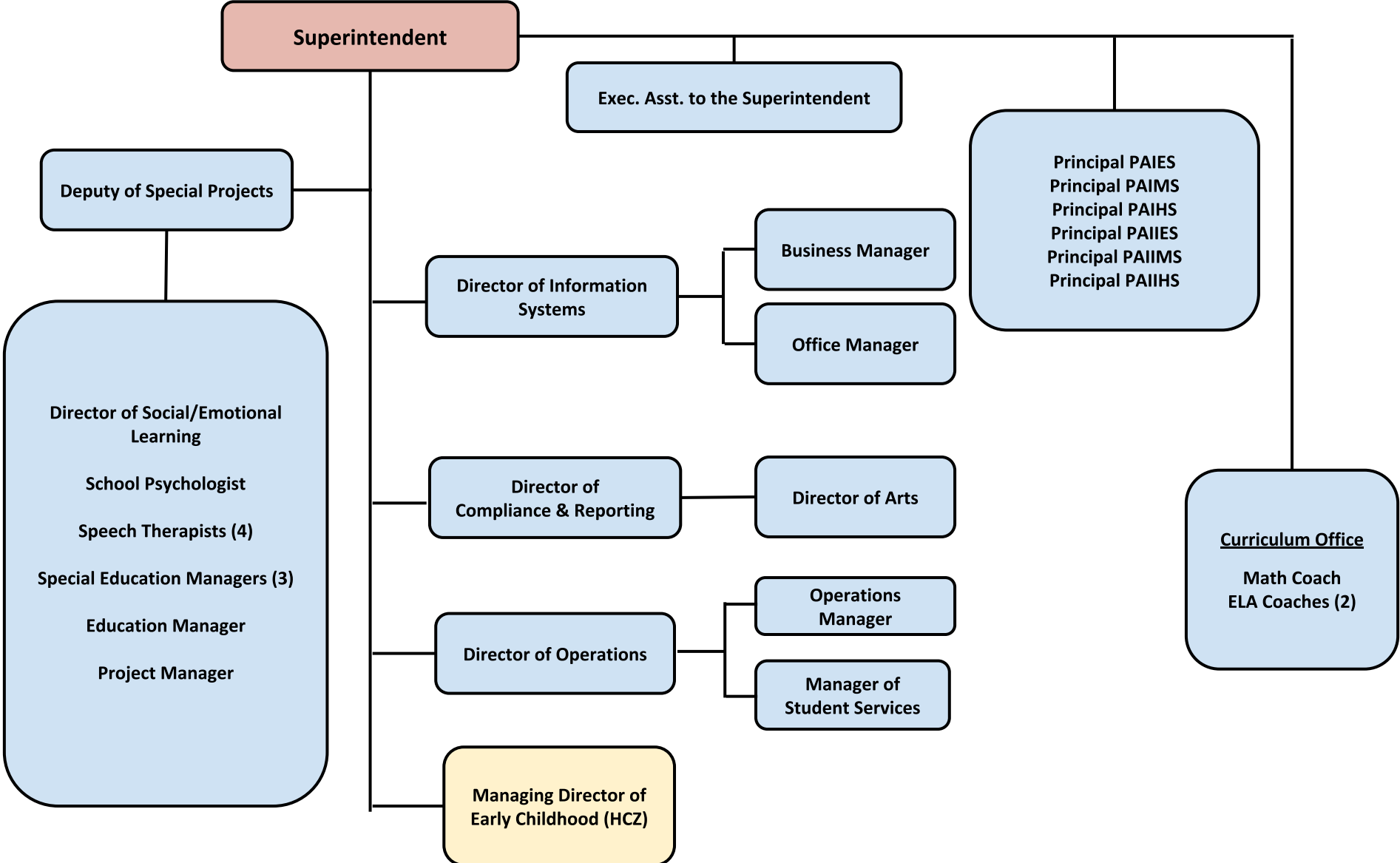
Virtual Learning Update (Amy Deal)

Promise Academy II Middle school principal, Amy Deal, spoke on the day in the life of teachers as they instruct scholars remotely.

Financial Update (Jim Hutter)
