#### **Acceptance of Minutes (Geoffrey Canada)**

The meeting was called to order at 7:30 a.m., and a motion to approve the meeting minutes from April 19, 2022, was unanimously approved.

#### **CEO Report (Kwame Owusu-Kesse)**

Chief Executive Officer Kwame Owusu-Kesse reported that the Recovery and Reopening Committee (RRC) team continues to track COVID-19 positivity rates across New York City and the Harlem community. In addition, Harlem Children's Zone (HCZ) continues to work with local health authorities as they provide home tests and guidelines around masking.

Mr. Owusu-Kesse also reported that on April 25, 2022, Bloomberg Philanthropies gave \$100 million in support to HCZ Promise Academy Charter Schools. The contribution, to be given over five years, will be instrumental in supporting the schools in the areas of mitigating learning loss, staff retention, social-emotional learning, wrap-around services, college support, scholarships, and more. Additional funds will be given to HCZ Promise Academy from Summer Boost NYC, which addresses the social and academic impact of COVID-19 on charter school students.

#### **Superintendent's Update (Dr. Achil Petit)**

Superintendent Dr. Achil Petit reported that enrollment is 1,128 for Promise Academy I and 1,023 for Promise Academy II.

Dr. Petit reported that grades three through eight scholars took the New York State (NYS) math exams at the end of April. Dr. Petit thanked senior staff members for volunteering to proctor and monitor exams, distribute snacks, and escort scholars to the restroom and school health center.

Dr. Petit also reported that Promise Academy celebrated Teacher Appreciation Week with celebratory events and gifts for the staff. Dr. Petit and Deputy Superintendent Dr. Saskia Brown are hosting an additional appreciation event for all Promise Academy and Early Childhood staff members on June 9.

#### **HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)**

Principal Dr. Joseph Cordero reported the Elementary School's attendance was 88% for April.

Scholars participated in The Butterfly Effect, an activity in which they tracked the metamorphosis of butterflies from larvae to adults. At the end of the experiment, the teacher guided the scholars in releasing the butterflies into the environment.

Scholars in grades three to five took the NYS math exams.

The Elementary School continued Language Essentials for Teachers of Reading and Spelling (LETRS) training to provide teachers with best reading practices in literacy instruction.

Teachers also held restorative practice sessions for scholars to refresh their knowledge in social-emotional learning.

Elementary School leaders had a Jam Session for parents to ask questions and talk about the expectations of scholars for the remainder of the school year.

The Elementary School celebrated Teacher Appreciation Week, providing staff members with breakfast and massages from Success in Motion, a wellness organization that partners with Promise Academy.

Elementary School administrative staff members have been working diligently on enrolling scholars at HCZ Promise Academy.

The Elementary School held a Top Performers ceremony for scholars who have achieved honor student status. Scholars also engaged in fun activities during Spirit Week.

#### **HCZ Promise Academy I Middle School (Madelaine German-Schultz)**

Principal Madelaine German-Schultz reported that the Middle School's attendance was 95% for April.

Middle School leaders joined the Elementary School's Jam Session to meet with parents of fifth-grade students and answer their questions about their scholars' transition to Middle School.

The Middle School's senior committee of eighth-grade scholars met with school leaders to finalize plans for their prom, graduation, and other related events.

The Middle School held a peer tutoring session in which high-performing scholars provided academic support to struggling peers.

The Middle School held its Math Olympics event to help scholars prepare for the NYS math exams.

For Teacher Appreciation Week, the Middle School provided its staff with breakfast, lunch, manicures, massages, and custom-printed jackets. Scholars also gave teachers notes with positive messages.

#### HCZ Promise Academy I High School (Amy Deal)

Principal Amy Deal reported that the High School's attendance was 91% for April.

The principal joined an eighth-grade Senior Committee meeting to connect with scholars in preparation for their transition to high school.

For Teacher Appreciation Week, the principal gave flowers and specialized notebooks to the administrative staff. In addition, teachers received lunch, custom printed clothing, and massages from Success in Motion. Education Director Anna Spoden created and implemented "warm and

fuzzy emails" with staff members receiving positive notes from their peers thanking them for their excellent work.

High School Assistant Principal Dr. Chanelle Cox took students in the National Honor Society to an HCZ Harvest event.

### **Financial Update (Connor Fournier)**

CFO Connor Fournier reported that Promise Academy I's enrollment is 1,128, which is on target versus the budget. The School's revenue is \$0.3M favorable versus the budget. Expenses are \$0.7M favorable at \$17.5M. HCZ has not made a contribution through ten months of FY22.

**RESOLVED**, that the FY 2023 Budget as presented is hereby approved.
