## Harlem Children's Zone Promise Academy I Charter School Board Meeting

#### **Acceptance of Minutes (Geoffrey Canada)**

The meeting was called to order at 7:30 a.m., and a motion to approve the meeting minutes from September 13, 2022, and June 15, 2022, was unanimously approved.

#### **CEO Report (Kwame Owusu-Kesse)**

Chief Executive Officer Kwame Owusu-Kesse reported that during the COVID-19 pandemic, the organization made the following achievements.

The Baby College held its 100th cycle this year. A foundational program of HCZ, it provides parenting education and support to families in Central Harlem. More than 650 parents have graduated from the program in the last three years.

HCZ Promise Academy celebrated 100% of its 300 scholars being accepted to college.

HCZ released the documentary *Harlem Rising*, which chronicles the organization's efforts to end generational poverty in Harlem.

Thanks to Mr. Canada's leadership, HCZ's William Julius Wilson Institute continues to scale the organization's impact nationally.

Plans to move Promise Academy II Elementary School to the Sendero Verde building in the winter are underway.

#### Superintendent's Update (Dr. Achil Petit)

Superintendent Dr. Achil Petit reported that enrollment is 1,142 for Promise Academy I and 1,016 for Promise Academy II.

Dr. Petit reported that Deputy Superintendent Dr. Saskia Brown conducted walk-throughs with the administrative teams in each of the Promise Academy schools to ensure that practices and procedures were consistent and lessons were enriching and engaging.

#### **State Test Scores**

Dr. Petit reported the results of state exams for grades three through eight, comparing pre-pandemic test results and current test results to demonstrate the impact of remote learning on scholars. Test results for 2021 dropped 22 percent in math for Promise Academy I and 32 percent in Promise Academy II compared with 2019 test results.

Despite the significant decline in math exam scores, Promise Academy outperformed its peers in the following groups: District 5, Black students, and students in New York City.

Promise Academy scholars were as proficient in English Language Arts (ELA) pre and post-pandemic. Promise Academy scholars outperformed their peers in the following groups: District 5, NYC Black students, and New York City students.

State comparison groups are not yet available.

#### **HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)**

Principal Dr. Joseph Cordero reported the Elementary School's attendance was 94% for September.

The character trait celebrated for the month was "individuality," highlighted by the book of the month, *I Color Myself Different* by Colin Kaepernick.

Elementary School scholars engaged in i-Ready and Independent Reading Level testing to identify those who may need additional support to meet academic benchmarks.

School leaders attended Promise Academy Parent Association (PAPA) meetings to support parent engagement and answer questions from families about practices and procedures at the Elementary School.

Dr. Cordero continues to hold virtual jam sessions with approximately 100 parents attending weekly.

Female scholars in grades two through four continue to participate in coding sessions with the Spence School for Girls. Terysa Ridgeway, Google's technical program manager and author of the children's book, *Think Like a Computer*, will present to the scholars next month.

The Elementary School started a culture committee for teachers to build community and morale.

Elementary School scholars received vision screening from Helen Keller International and the New York State Department of Health. Scholars who require them will receive glasses.

Dr. Cordero thanked CHECS, Community Pride, and a group of Promise Academy High School scholars for assisting the Elementary Schools with recruitment efforts at the Sendero Verde property.

#### **HCZ Promise Academy I Middle School (Madelaine German-Schultz)**

Principal Madelaine German-Schultz reported that the Middle School's attendance was 94% for September.

The Middle School held parent-teacher conferences, offering a virtual option for parents who could not attend in person. 70% of parents attended the parent-teacher conferences.

The Middle School also held a Student Council election. Scholars gave speeches to campaign for their elections.

The Health Center continues to be an important resource for Middle School scholars who need health services.

#### **HCZ Promise Academy I High School (Amy Deal)**

Principal Amy Deal reported that the High School's attendance was 94% for September.

To encourage positive behaviors and set expectations, the High School used Kickboard, an app used to highlight academic success, positive interactions, behavioral trends, and other daily activities with scholars and families. Scholars who gain points in Kickboard are able to use them to buy items from the school store.

The High School held a back-to-school night with parents to engage with college representatives from SUNY Oswego, Dartmouth, and Boston College. Over 30 scholars attended a college fair at the Javitz Center. Seniors will attend a college tour in the coming months.

Scholars are currently campaigning for positions in the student government.

The National Honor Society met with high school scholars. Scholars also engaged in community service, helping the Elementary School with lunch and dismissals.

#### Financial Update (Connor Fournier)

CFO, Connor Fournier, reported that Promise Academy I's enrollment is 1,142, which is ten favorable versus the budget. The school's revenue is on track with the budget at \$5.7M. Expenses are \$0.1M unfavorable at \$5.5M. HCZ has not made a contribution through three months of FY22.
