Acceptance of Minutes (Geoffrey Canada)

The meeting was called to order at 7:30 AM, and a motion to approve the meeting minutes from February 15, 2023, was unanimously approved.

CEO Report (Kwame Owusu-Kesse)

Chief Executive Officer Kwame Owusu-Kesse reported that he recently launched a clarification of Harlem Children's Zone's (HCZ) Core Beliefs and Values: Children First, Servant Leadership, and Place Matters. The HCZ team developed a rollout plan, which included town halls for staff to ask questions. Mr. Owusu-Kesse thanked the Communications and Executive teams for their hard work and contributions to this initiative.

Superintendent's Update (Dr. Achil Petit)

Superintendent Dr. Achil Petit reported that enrollment is 1,113 for HCZ Promise Academy I and 984 for HCZ Promise Academy II.

Dr. Petit also reported that the HCZ Promise Academy Elementary School team collaborated with the Early Childhood team to discuss enrollment strategies. In addition, open house events were held to inform the community about HCZ Promise Academy Charter Schools and answer parents' questions.

Deputy Superintendent Dr. Saskia Brown held a luncheon for five school staff members with perfect attendance. They also received an Amazon gift card for their dedication.

HCZ Promise Academy II Elementary School (Amanda Neal)

Principal Amanda Neal reported the Elementary School's attendance was 89% for February.

In partnership with the Social Emotional Learning team, the Elementary School held a Fish Bowl event with staff members, who had the opportunity to voice concerns to the administrative team, share their thoughts, and celebrate their coworkers.

Before the mid-winter break, a Glow Dance and lunch were held for 25 fourth- and fifth-graders to reward them for perfect attendance and consistent participation in Saturday Academy. Principal Neal thanked Executive Chef Andrew Benson for providing lunch.

Over 100 prospective scholars and their families attended the Open House at the Elementary School's new location, 70 East 112th Street.

HCZ Promise Academy II Middle School (Ryan Carroll)

Principal Ryan Carroll reported that the Middle School's attendance was 93% for February.

The Middle School held Spirit Week to celebrate Black History Month, where scholars dressed up to match the theme of each day.

The Middle School had school photographs taken for the year.

State exam preparation is underway, with scholars taking ELA mock exams. Dr. Petit, Dr. Brown, and the Curriculum and Instruction team met with Middle School leaders and teachers to plan test preparation. On February 10, school leaders held a professional development session to discuss State test grading procedures, align on best practices, and analyze the Next Generation Standards.

The Middle School celebrated Counselor's Week, presenting the School's guidance counselor with an Edible Arrangement and messages of thanks from staff and scholars.

HCZ Promise Academy II High School (Kaitlynn Conwright)

Principal Kaitlynn Conwright reported that the High School's attendance was 94% for February.

The High School's Student Government held its Valentine's Day Dance for scholars who met expectations for attendance and behavior. The event closed with scholars sharing the names of those they had lost over the past two years in remembrance of their loved ones.

The High School celebrated high-achieving scholars, with school leaders taking 15 scholars to Dave and Buster's.

High School seniors completed their scholarship applications.

Financial Update (Connor Fournier)

CFO, Connor Fournier, reported that Promise Academy II's enrollment is 984, which is 50 unfavorable versus the budget. The school's revenue is \$0.5M unfavorable at \$13.9M. Expenses are \$0.9M favorable at \$13.9M. HCZ has not made a contribution through eight months of FY23.
