Harlem Children's Zone (HCZ) Promise Academy II Charter School Board Meeting Tuesday, May 16, 2023 245 West 129th Street

Acceptance of Minutes (Geoffrey Canada)

The meeting was called to order at 7:30 AM, and a motion to approve the meeting minutes from April 18, 2023, was unanimously approved.

CEO Report (Kwame Owusu-Kesse)

Chief Executive Officer Kwame Owusu-Kesse attended Harlem Children's Zone's College Signing Day event at the HCZ Armory, which hosted nearly 200 scholars. The families and scholars expressed gratitude and excitement.

Mr. Owusu-Kesse also reported that on May 15, he attended Robin Hood's Annual Benefit. The Robin Hood Foundation, New York City's largest poverty-fighting organization, partners with over 250 nonprofits to support food, housing, education, and more across all five boroughs.

Superintendent's Update (Dr. Achil Petit)

Superintendent Dr. Achil Petit reported that enrollment is 1,108 for HCZ Promise Academy I and 978 for HCZ Promise Academy II.

Dr. Petit also reported that both HCZ Promise Academy Charter Schools are beginning their charter renewal process. Senior Director Dr. Raisa Schwanbeck, from the New York City Department of Education's Charter School Office, visited in May with her team. The charter renewal applications for both Schools are due on September 1, 2023.

Scholars took the state math exams in the first week of May. Dr. Petit thanked the HCZ Promise Academy Central Office for supporting schools during the exams.

HCZ Promise Academy held a Spring Leadership Retreat, allowing School leaders to work on Objectives and Key Results (OKRs) and align with the organization's strategic plans.

HCZ Promise Academy celebrated staff during Teacher Appreciation Week. Board Chair Geoffrey Canada, Dr. Petit, and Deputy Superintendent Dr. Saskia Brown made a video thanking everyone for their hard work and announced a special treat for all staff. The video will be released on May 22.

At the end of June, Dr. Joseph Cordero will leave his role as Principal of HCZ Promise Academy I Elementary School. Dr. Petit thanked Dr. Cordero for his 12 years of service. Dr. Cordero expressed his love for the scholars and the community.

HCZ Promise Academy II Elementary School (Amanda Neal)

Principal Amanda Neal reported the Elementary School's attendance was 91% for April.

The Elementary School welcomed the HCZ Promise Academy Parent Association (PAPA) Board members to 70 East 112th Street for a tour of the new building.

Scholars in grades three through eight took the state math exams in April.

Kindergarten scholars visited the Hostos Center for the Arts & Culture Shadow Box Theater to see *The Earth & Me*, a show about protecting the Earth through harmony, tolerance, and peace. First-grade scholars attended a performance at Hunter College by The Paper Bag Players. Second-grade scholars visited the FDNY Fire Zone at Rockefeller Center.

The School's science lab acquired dart frogs and quail after scholars wrote essays on the animals they wanted in the lab.

HCZ Promise Academy II Middle School (Ryan Carroll)

Principal Ryan Carroll reported that the Middle School's attendance was 94% for April.

In April, the Middle School closed its third marking period with ceremonies to highlight subject award winners, perfect attendance, citizenship, and the most improved scholar.

The Middle School celebrated all staff members during Teacher Appreciation Week. Administrators received lunch, Edible Arrangements, gift cards and a customized clipboard, and cards signed by staff members.

Scholars completed their math state exams in early May. Principal Carroll expressed thanks to the HCZ Promise Academy Central Office team for their support during the exams.

HCZ Promise Academy II High School (Dr. Saskia Brown)

Deputy Superintendent Dr. Saskia Brown reported that the High School's attendance was 91% for April.

High School scholars completed Advanced Placement testing in May. Principal Conwright thanked all staff members who supported scholars in Saturday Academy and Academic Hour.

During Teacher Appreciation Week, staff members focused on self-care and were provided breakfast, lunch, and customized swag. Principal Conwright thanked Dr. Petit and Dr. Brown for their support.

High School seniors attended HCZ's College Signing Day, where they received prizes and giveaways. Graduating seniors will attend colleges and universities in the fall, such as Morgan State University and Hampton University.

Last month, scholars received financial awards during the Jordan Wings Scholars Program award ceremony. Principal Conwright thanked the Communications and Development teams, the Center for Higher Education and Career Support, and Wealth Builds for their efforts and support.

100% of the School's seniors were accepted to college.

Financial Update (Connor Fournier)

CFO, Connor Fournier, reported that Promise Academy II's enrollment is 978, which is 56 unfavorable versus the budget. The school's revenue is \$0.6M unfavorable, at \$17.4M. Expenses are \$1.1M favorable, at \$16.3M. HCZ has not made a contribution through ten months of FY23.
