# Harlem Children's Zone (HCZ) Promise Academy I Charter School Board Meeting Tuesday, May 16, 2023

245 West 129th Street

#### **Acceptance of Minutes (Geoffrey Canada)**

The meeting was called to order at 7:30 AM, and a motion to approve the meeting minutes from April 18, 2023, was unanimously approved.

#### **CEO Report (Kwame Owusu-Kesse)**

Chief Executive Officer Kwame Owusu-Kesse attended Harlem Children's Zone's College Signing Day event at the HCZ Armory, which hosted nearly 200 scholars. The families and scholars expressed gratitude and excitement.

Mr. Owusu-Kesse also reported that on May 15, he attended Robin Hood's Annual Benefit. The Robin Hood Foundation, New York City's largest poverty-fighting organization, partners with over 250 nonprofits to support food, housing, education, and more across all five boroughs.

#### Superintendent's Update (Dr. Achil Petit)

Superintendent Dr. Achil Petit reported that enrollment is 1,108 for HCZ Promise Academy I and 978 for HCZ Promise Academy II.

Dr. Petit also reported that both HCZ Promise Academy Charter Schools are beginning their charter renewal process. Senior Director Dr. Raisa Schwanbeck, from the New York City Department of Education's Charter School Office, visited in May with her team. The charter renewal applications for both Schools are due on September 1, 2023.

Scholars took the state math exams in the first week of May. Dr. Petit thanked the HCZ Promise Academy Central Office for supporting schools during the exams.

HCZ Promise Academy held a Spring Leadership Retreat, allowing School leaders to work on Objectives and Key Results (OKRs) and align with the organization's strategic plans.

HCZ Promise Academy celebrated staff during Teacher Appreciation Week. Board Chair Geoffrey Canada, Dr. Petit, and Deputy Superintendent Dr. Saskia Brown made a video thanking everyone for their hard work and announced a special treat for all staff. The video will be released on May 22.

At the end of June, Dr. Joseph Cordero will leave his role as Principal of HCZ Promise Academy I Elementary School. Dr. Petit thanked Dr. Cordero for his 12 years of service. Dr. Cordero expressed his love for the scholars and the community.

#### **HCZ Promise Academy I Elementary School (Dr. Joseph Cordero)**

Principal Dr. Joseph Cordero reported the Elementary School's attendance was 94% for April.

The Elementary School held a Spring Fling for scholars whose behavior improved. Scholars played games and created artwork.

Scholars took class pictures for the school year.

Second-grade scholars took a trip to the HCZ Armory, where they engaged in fun activities.

School leaders attended the HCZ Promise Academy Leadership Retreat and discussed their OKRs for the upcoming school year.

The Elementary School held a pep rally to promote positive engagement for the state math exams.

The Elementary School celebrated Teacher Appreciation Week with daily raffles, breakfast, lunch, and a snack cart for teachers and staff.

The enrollment period was successful, with more than 90% of all kindergarten scholars fully enrolled for the new school year. School administrators continue to work on enrolling scholars from the waitlists of the remaining elementary grades.

The principal continues to hold Just A Moment sessions to give parents the opportunity to ask questions.

#### HCZ Promise Academy I Middle School (Madelaine German-Schultz)

Principal Madelaine German-Schultz reported that the Middle School's attendance was 95% for April.

With the support of the Social Work Team, the Middle School has partnered with Educational Alliance to create community-based prevention programs to teach scholars about substance abuse. Educational Alliance offers services to diverse communities to enhance well-being and socioeconomic opportunities.

The Middle School partnered with the Social Emotional Learning team to create a platform that teaches parents different ways to help their scholars navigate social issues, such as the appropriate use of social media.

The Middle School initiated bi-weekly Fun Fridays to reward scholars for their hard work on the state exams.

#### **HCZ Promise Academy I High School (Dr. Saskia Brown)**

Deputy Superintendent Dr. Saskia Brown reported that the High School's attendance was 93% for April.

For Teacher's Appreciation Week, the High School held several events to honor teachers and administrators, including the Warm and Fuzzy Notes wall, where scholars left appreciative notes for the staff. School leaders also provided breakfast, lunch, and snacks during celebrations.

On May 11, seniors attended HCZ's College Signing Day, hosted by the Center for Higher Education and Career Support at the HCZ Armory.

#### **Financial Update (Connor Fournier)**

CFO, Connor Fournier, reported that Promise Academy I's enrollment is 1,108, which is 24 unfavorable versus the budget. The school's revenue is \$0.2M unfavorable, at \$18.9M. Expenses are \$0.9M favorable, at \$17M. HCZ has not made a contribution through ten months of FY23.
