### WAIVER

I, the parent/guardian of the child named above, hereby give my permission for my child to participate in Harlem Children's Zone Summer Games 2023, including, but not limited to transportation to and from the New Balance Track and Field Center at the Armory. I know Harlem Children's Zone and New Balance Track and Field Center at the Armory events are potentially hazardous activities. My child should not enter and participate unless medically cleared and properly trained. I agree to abide by any decision of an event official relative to my child's ability to safely compete. My child is voluntarily entering, and we knowingly and voluntarily assume all risks associated with participating in the event, including, but not limited to falls, contact with other participants, spectators, or others, and the conditions of the track and surrounding areas, including any resulting illness or injury; all such risks are fully known and appreciated by us. Having read this waiver and knowing these facts, and in consideration of your acceptance of this application, I for myself, my child, and anyone entitled to act on our behalf, to the fullest extent permitted by law waive and release Harlem Children's Zone, Inc., its Board, Board members, affiliates, partners, directors, officers, employees, representatives, and agents and New Balance Track & Field Center at the Armory ("Released Parties"), from all present and future injuries, losses, causes of action, claims, liability, or expenses, including, but not limited to the extent caused or contributed to by any negligence or fault of any of the Released Parties (collectively, "Claims") that may arise in whole or in part out of or in connection with my child's participation in Harlem Children's Zone Summer Games 2023, the related transportation, supervision, care, or acts or omissions of the Release Parties, regardless of when such claims may arise.
